HOW TO ENTER

- The child can tell the story, which is written down by an adult, or the child can print their own story.
- The child can illustrate the story. (Illustrations are not required.)
- A parent or guardian must complete the entry form and sign the acknowledgement of contest rules.
- A completed entry form, story, and illustration(s) should be submitted to the Findlay-Hancock County Public Library.

WHO CAN SUBMIT A STORY?

- Children who will be in kindergarten through 5th grade by January 1, 2024 may submit a story.
- Children must live in Hancock County, OH or be associated with Findlay City Schools, the Hancock County School District, or another school in Hancock County, OH.

WHEN MUST THE STORY BE SUBMITTED?

- We'll start accepting stories on Thursday, February 1, 2024. **All stories must be received by Thursday, February 29, 2024.**

JUDGING & PRIZES

- Entries will be judged by community advisors. All decisions of the judges are final and not subject to appeal or review.
- Prizes will be awarded to first, second, and third places in each grade at an awards celebration on **April 15, 2024**.
- Winners will be notified by email or phone, and winners' names will be posted on our website by **April 1, 2024**.

COVER ILLUSTRATION CONTEST!



The Mazda Museum will be sponsoring cover illustration prizes for first, second, and third places in each grade level. Cover illustrations must be sent in with a story in order to qualify for the cover illustration portion. Only cover illustrations will be judged for the cover illustration award.

WHAT ARE THE CONTEST RULES AND REGULATIONS?

- The story must be no more than 350 words.
- The story must be written in the English language.
- The story may be typed or handwritten but it must be legible. Children who cannot write may dictate their story to be typed or handwritten legibly.
- Illustrations or cover art are encouraged but not required.
- Only one entry per person—after the first entry received, all other entries by the same child will be disqualified.
- A story may have one person write and another person illustrate. That entry will count as the sole entry for both people.
- Only one-author stories qualify (no co-authored stories).
- Only one-illustrator stories qualify (no co-illustrated stories).
- The story must be wholly the original work of the entrant, written solely by the entrant. It cannot be copied from any other source.
- The story cannot be in violation of or in conflict with the trademark, copyright, rights of privacy, rights of publicity, or any other rights, of any kind or nature, of any other person or entity.
- The story must not have been previously broadcast or otherwise distributed or disseminated in any media or format.
- The story must not include any language or other content that is inappropriate, offensive, or otherwise unfit for dissemination or broadcast, as determined by the Tell-A-Tale Committee in its sole discretion.
- Any submitted stories and/or illustrations may be published in print and digitally on the Findlay-Hancock County Public Library website and Facebook page. Published stories/illustrations will include the child's full name, school, and grade.
